- "Power to methanol: Role of cluster= promote certification of "green" methanol, influence policymakers
- Power to gas Roadmap study for Flanders will be published on website <u>www.power-to-gas.be</u> beginning of October.
- To get European subsidies, one has to take into account a lead time of about one year (between first concept note and final approval); to realise projects within 3 years time we should submit already some concept proposals end of 2016-beginning of 2017.
